- (a) The objects of the Corporation provided for in the Letters Patent of the Corporation dated

June 8, 1971 are hereby deleted and replaced by the following:

- (i) To create and maintain an association of real estate appraisers within the Province of Ontario and for that purpose to establish, promote and advance the standards of appraisal, valuation and other consulting services relating to real property of all kinds;
- (ii) To establish, promote and advance the interests of those engaged in the appraisal and valuation of real property of all kinds;
- (iii) To print and circulate such publications and other material as may seem conducive to the objects of the corporation;
- (iv) To create, stimulate and increase public interest in matters of real property appraisal and valuation;
- (v) To co-operate with any organization having similar or like means and objects;
- (vi) To acquire by purchase, lease or otherwise, land and buildings and all other property, real and personal, which the Corporation, for the purpose thereof, may, from time to time, think proper to acquire, and which may lawfully be held by it and to resell under lease or sublet, surrender, turn to account or dispose of such property or any part thereof and to erect upon any such land any building and to alter or add to any building erected upon any such land for the purpose of the Corporation;
- (vii) To enter into partnership or enter into any arrangement for sharing of profits, union of interest, co-operation, joint venture, reciprocal concession or otherwise with any person or company carrying or engaged in or about to carry on or engage in any business or transaction that the Corporation is authorized to carry on or engage in or any business or transaction capable of being conducted so as to benefit the Corporation;
- (viii) To establish and support or aid in the establishment and support of the benefit and programs for the benefit of members of the Corporation;
- (ix) To establish training and education programs for the members of the Corporation.
